Notification of Changes

Sub-Processor Requirements

Vasion requires its sub-processors to satisfy equivalent obligations as those that apply legally or contractually to Vasion (as a Data Processor), all as set forth in [Vasion's Data Processing Agreement \("DPA"\)](#), including but not limited to the following requirements to:

- Process personal data only in accordance with documented instructions
- Implement appropriate technical and organizational measures to protect personal data
- Assist Vasion in meeting its obligations under applicable data protection laws
- Delete or return all personal data after the end of the provision of services
- Submit to audits and inspections as required by law.
